#### **Academics**

#### • Senior Data:

- 121 Students failed at least 1 class trimester 2
- 70 students failed a Trimester 2 course needed for Graduation
- 60 students are on track to earn Advanced Regent Diploma
- 34 additional students have potential to earn an Advanced Regent Diploma

#### Senior Data: T1 Credit Recovery Night School

- 52 students signed up
- 27 students completed at least 1 course
- 8 Students recovered all of their T1 credits

# College

- 149 students applied to college
- 43 students accepted into 1 or more college
- 11 students do not have a post secondary plan (team is continuing to work with those students to plan)
- 10 attending trade school, military, work
  - 5 taking a gap year or are not interested in college/post secondary assistance. All parents are aware and support the student's post secondary plan.
- 149 Students applied to CUNY 26 were accepted
- 70 Students applied to SUNY 13 were accepted
- We are planning to hold another FAFSA workshop for families

 We have started master scheduling tasks for next school year.





COVID positivity 11206 Zip Code = 5.34% (from 4/16-4/22/21) per www1.nyc.gov





### **COVID Safety & Emergency Preparedness**

#### Updates

ALL DOE employees, visitors, and families must complete a health screening before entering DOE facilities. This health screening must be completed on each day of arrival. This health screening can also be completed online at: <a href="https://healthscreening.schools.nyc/">https://healthscreening.schools.nyc/</a>. Upon entering the facility, if you have not completed the online health form you will be asked to provide responses to the questions below.

- 1. Have you experienced any symptoms of COVID-19, including a fever of 100.0 degrees F or greater, a new cough, new loss of taste or smell or shortness of breath that started in the past 10 days?
  - □ No. Go to the next question.
  - Yes, and I have received a lab-confirmed negative result from a COVID-19 diagnostic test (not a blood test) since the onset of symptoms AND have not had symptoms for at least 24 hours. Go to the next question.
  - Yes, and I am not in the category above. No further screening is needed. The employee/guest may not enter the building.
- 2. In the past 10 days, have you gotten a lab-confirmed positive result from a COVID-19 diagnostic test (not a blood test) that was your first positive result OR was AFTER 90 days from your previous diagnosis date?<sup>1</sup> Please note that 10 days is measured from the day you were tested, not from the day when you got the test result.
  - □ No. Go to the next question.
  - □ Yes. No further screening is needed. The employee/guest may not enter the building.
- 3. Are you considered fully vaccinated against COVID-19 by CDC guidelines OR were you recently (within the past three months) diagnosed with COVID-19 and finished isolation in the past 90 days<sup>2</sup> AND you have not traveled internationally in the past 10 days? Please note that to be considered fully vaccinated by CDC guidelines, two weeks must have passed since you received the second dose in a two-dose series or two weeks must have passed since you received a single-dose vaccine.<sup>3</sup>
  - □ No, I am not considered fully vaccinated. Go to the next question.
  - No, I am considered fully vaccinated or was diagnosed with COVID-19 in the past 90 days BUT I have traveled internationally in the past 10 days. The employee/guest can skip question 4 and must answer question 5.
  - □ Yes. The employee/guest does not need to answer questions 4 and 5 and may enter the building.

The NYC DOE updated health screening form to reflect updated quarantining and vaccination protocols for schools in **shared spaces**.

#### **Updates**

#### School Plans

- Prior to making any change to reduce physical distancing to less than 6 feet between students during academic instruction, decisions must be made with community input. Ultimately, the school/district's decision to move to shorter physical distances will come down to a local community's risk tolerance based on its unique circumstances.
- All plans should continue to reflect engagement with school stakeholders and community members (e.g., administrators, faculty, staff, students, parents/legal guardians of students, local health care providers, and affiliated organizations, such as unions, alumni, and/or community-based groups), particularly local health department(s), and, in accordance with the minimum requirements referenced herein, cover:
  - 1. Reopening of school facilities for in-person instruction
  - 2. Monitoring of health conditions
  - 3. Containment of potential transmission of COVID-19, and
  - 4. Closure of school facilities and in-person instruction, if necessitated by widespread virus transmission.
- The NYS Department of Health does not review or approve revisions to school reopening plans, however plans must be consistent with DOH guidance.
- Modified plans must be posted online as well as submitted to the New York State Education Department and the Local Health Department. Local Health Departments are the entity charged with enforcement of these minimum guidelines.

#### April 14, 2021

## Exceptions where a minimum of 6 feet of distance must be maintained

- Between adults (teachers, staff, visitors) <u>and</u> between students and adults.
- When eating meals or snacks, drinking, or other times masks must be removed. This may mean meals cannot be eaten in classrooms that have been converted to 3 feet of physical distancing during instruction time.
- Activities that require projecting the voice (e.g., singing) or playing a wind instrument must be 6 feet apart, and there must be 6 feet of distance between performers and audience members.
- In common areas outside of the classrooms (e.g., lobbies, auditoriums, cafeterias, hallways), where possible.

#### Safety

- No reports of any cyber incidents
- No reports of any criminal activity at the local Morgan Avenue subway station
- The NYPD transit and 90th PCT were alerted to the schools opening and time schedule
- Daily temperature screening was conducted for Staff & Visitors



#### **Facilities**

- The school is prepared for air conditioning service when needed
- All classrooms window screens were repaired
- All classrooms windows were installed with locks to allow 4.5 inches of required opening space
- Covid PPE supplies are available for Students & Staff
- Repairs were made to the schools City water pump
- No leaks or other conditions to report at this time
- Fire Department hearing scheduled for 5/14/21 due to unwarranted alarms.(Fineable violation)


